Section 1

COMMUNITY DESCRIPTION

Location and Regional Context

The Village of Ellsworth is located within the geographic boundaries of Banks Township in northwest Antrim County. Banks Township is the northwestern most township in Antrim County, which is bounded on the west by Lake Michigan, and by portions of Charlevoix County on the north and east. Antrim is located in the northwest region of Michigan's Lower Peninsula. According to the Census information, Banks Township comprises approximately 45 square miles, of which the Village of Ellsworth comprises 0.7 square miles, and for reference Antrim County is 476.9 square miles in area. Figure 1-1 illustrates the location of Banks Township and the Village of Ellsworth in relation to Antrim County and the State of Michigan.

The Village of Ellsworth was incorporated as a village late in its history. In 1902, the election board of Banks Township was organized. In March 1938, the citizens voted 50-6 to petition the Township Board of Supervisors to incorporate the village. A special election was held on the proposal for incorporating the village and the election of the members of Charter Commission, in November 1938.

Population


According to the U.S. Census Bureau, the population in 2000 for the Village of Ellsworth was 483 persons (237 male and 246 female) and for Banks Township was 1,813 persons (917 male and 896 female), averaging approximately 40.3 persons per square mile for the Township's 45 square miles of land area. This population density can be compared to approximately 48.5 persons per square mile for Antrim County and 175.0 persons per square mile for the State of Michigan.

In discussing the population for the Village of Ellsworth and Banks Township, however, it is important to note that the figure presented by the 2000 Census does not reflect the actual number of persons residing in the Township during the summer months. This situation can be seen throughout much of northern Michigan. The Census tally, taken on April 1st, does not count residents who winter elsewhere. Respondents are asked to declare a permanent residence different from their April location, if more than six months are spent at the alternate address. However, many fail to do so for reasons of misunderstanding or for tax purposes.

In reviewing the social and economic information derived from Census data, the figures presented for housing characteristics show 267 units or 26.8 percent of the total housing units as seasonal, recreational, or occasional use homes. With this in mind, it can be assumed that the Township's resident population significantly increases during the summer months. Based on the average household size in Banks Township of 2.63, if the seasonal households are occupied by the same average number of persons per household the expected seasonal increase would be an additional 702 persons. In addition, many summer visitors stay at private lodging places or at the homes of family or friends.

Recreation

The recreation opportunities in the Village and Township are detailed in Section 3 of this plan, but in general consist of water-related activities (boating, fishing, swimming, etc). There are public access sites on Lake Michigan, Ellsworth Lake and Lake St. Clair within the Township and Village that are well utilized both in the summer and winter seasons. Within Ellsworth Community Park provides a variety of amenities and Antrim Creek Natural Area provides nature trails for hiking and skiing, with hunting and fishing allowed during permitted seasons. Wooden Shoe Park operated by the Village of Ellsworth offers 40 electrified campsites and 15 rustic campsites. Additionally, Whistling Pines, a privately owned campground offers 15 campsites.



Section 2 ADMINISTRATIVE STRUCTURE

Administrative Structure and Funding in Banks Township and the Village of Ellsworth

Banks Township and the Village of Ellsworth have re-established a Parks and Recreation Committee that oversees the general operation of the township and village parks and recreation programs. This Committee will provide recommendations regarding park policies and projects to the Township Board and Village Council, as appropriate.

The Parks and Recreation Committee will serve as a community sounding board on recreation matters, and bring the concerns of the residents to the Township Board and/or Village Council for consideration. Routine park maintenance is handled by the Township and Village staff, contractors and volunteers, operating under the direct authority of the Township Board and/or Village Council.

The ultimate decision-making authority and responsibility for all park related projects resides with the Township Board and/or Village Council depending on the particular project.

<u>Volunteers</u> will be an integral part of the recreation projects in the Village of Ellsworth and Banks Township. While there is not a designated volunteer group, volunteers are solicited on a project by project basis to provide some of the labor for the Township "in-kind" match on projects as appropriate. For lake related projects and Tip of the Mitt Watershed Council are expected to be active partners.

<u>Relationships:</u> This recreation plan covers Banks Township, including the Village which includes portions of three public school districts. All of the Village and most of Banks Township is served by Ellsworth Community Schools. A small area in the northwest portion of the Township is served by Charlevoix Public Schools; additionally a small area along the southern portion of the Township is served by Central Lake Public Schools.

Banks Township and the Village of Ellsworth will be working cooperatively with the Top of Michigan Trails Council, Antrim County and Charlevoix County to pursue the development of non-motorized trails and bike lanes, in order to most effectively develop local routes that connect with the larger trail system in northern Michigan.

Antrim County adopted a recreation plan in December 2010, however in order for the Village of Ellsworth and Banks Township to pursue Township and Village recreation goals on an accelerated time frame, the Township and Village have decided jointly prepare an updated Community Recreation plan.

The Village and Township Recreation Plan does include provisions to continue and enhance the working relationship with Antrim County, the Grand Traverse Regional Land Conservancy, other local conservancies, local Tribal Governments and Michigan Department of Natural Resources as related to the other recreation facilities located within Banks Township and/or Village of Ellsworth.

Status Report of all Grant-Assisted Parks and Recreation Facilities

Based on information provided by the DNRE, the Village of Ellsworth has received two parks and recreation related grants in the past, and Banks Township has not independently received any grants.

In 1985, the Village of Ellsworth received grant #26-01411 for improvements to Wooden Shoe Park (campground). The included improvements included upgraded accessible restroom and shower facilities, as well as dump station and septic system.

In 2006, the Village of Ellsworth received grant # TF 06-092, for the development of the Ellsworth Community Park. The grant-funded improvements included accessible restrooms, a pavilion with electricity, play area, trail, wildlife viewing area, fishing pier, boat dock, an archery range and a parking area.

Public Input

No written comments were received on the proposed Community Recreation Plan, and only two persons attended the public hearing. A copy of the public hearing minutes are included in Appendix A.

Adoption Process

The Parks and Recreation Committee held a public hearing on the Recreation Plan on March 14, 2011. The Committee subsequently adopted the plan on March 14, 2011.

Recreation Plan adoption resolutions

The Recreation Plan was adopted by the Ellsworth Village Council and by the Banks Township Board of Trustees on March 21, 2011 and a copy of the respective meeting minutes are included in Appendix B.

Recreation Plan Certification

A copy of the Recreation Plan Certification is in Appendix C provided on pages C-2 & C-3.

Transmittals to the County Planning Department and regional planning agency.

A copy of the adopted plan was transmitted to the Antrim County Planning Department and a copy to the Northwest Michigan Council of Governments on March 24, 2011, a copy of each transmittal letter is provided in Appendix B.

SECTION 3 RECREATION INVENTORY

Inventory of Recreation Facilities in Banks Township including the Village of Ellsworth

An inventory of existing recreation facilities located in Banks Township and those within the Village of Ellsworth are provided below. Sites are grouped according to jurisdictional ownership. Township owned facilities are listed first, followed by Village owned facilities then other public sites, and finally privately owned recreation sites. Each listing is followed by a brief description of that location. Figures 3.1 illustrate the location of the public sites.

Banks Township owns the Township Hall property which is less than one acre in size and has meeting rooms.





SECTION 4

DESCRIPTION OF THE PLANNING AND PUBLIC INPUT PROCESS

Planning Process

Prior to this Recreation Plan, Banks Township and the Village of Ellsworth had a recreation plan which expired in 2005.

The Township and Village decided late in 2010 to prepare an updated joint Recreation Plan. Since the Recreation Committee which was involved in the development of the previous plan had not been active in recent years, a new Recreation Committee was appointed in December 2010. The Recreation Committee worked with a consultant to prepare this plan during a series of meetings open to the public. The draft sections of the plan were discussed and revised at these public meetings. A public hearing on the recreation plan was held on March 14, 2011. The preliminary draft plan was posted on the Township website and made available at the public hearing. Minutes from the public forum/public hearing are included in Appendix B.

The plan was adopted by the Recreation Committee on March 14, 2011, and by the Banks Township Board of Trustees on March 21, 2011, and by the Village of Ellsworth Council on March 21, 2011.

SECTION 5

RECREATION GOAL AND OBJECTIVES

The recreational goal and objectives presented below are the result of the Planning Commission master planning process, the public input received during that process, and the further refinement and expansion during the subsequent recreation plan development.

GOAL:

Provide a recreation system, responsive to the needs and desires of present and future residents of Banks Township and the Village of Ellsworth

OBJECTIVES:

- Acquire, develop, operate and maintain the Township and Villages parks.
- Promote the overall coordination of resources within the parks and recreation system.
- Provide a system that keeps pace with the growing demand for recreational activities.
- Where possible, encourage multiple use for recreation areas, open space areas, forest lands and flood plains.
- Encourage private land donations for public parks and recreation purposes.
- Pursue available funding for recreational development.
- Partner with the private sector to develop facilities complementing public uses.
- Promote interpretive and educational programs to foster appreciation and understanding of the outdoors, such as archery instruction.
- Promote the importance of recreation as a contributor to the improvement of the quality of life, including the pursuit of "complete streets' policies for both the Village and the Township.
- Develop a plan that identifies a system of open space areas in the communities, consistent and compatible with the County's goals and policies.

GOAL:

Encourage the development of recreation areas and programs that consider proper utilization of natural resources without environmental damage.

OBJECTIVES:

- Encourage the use of flood plain and wetland areas for open space activities such as wildlife refuges, hunting and fishing areas, and passive recreational activities.
- Promote the development of designated areas for recreational vehicles to minimize damage to rivers, streams, lakes and forests.
- Encourage commercial recreation development in such a manner that minimizes conflicts with adjoining land uses.
- Promote awareness of invasive species and encourage the use of native plants.
- Identify and preserve scenic and unique natural areas, while providing reasonable access.

GOAL:

Encourage the development of age appropriate recreation opportunities for the changing demographics of the Township and Village.

OBJECTIVES:

- Survey the community members to determine the unmet recreational needs.
- Pursue development of the identified recreation facilities.
- Stabilize lakefront shoreline at Banks Township Park to reduce erosion risks and allow for environmentally sensitive development.

GOAL:

Identify and preserve historic and archaeological elements within the Township and Village

OBJECTIVES:

- Increase awareness of identified historic and archaeological areas.
- Pursue funding for preservation of historic and archaeological sites.
- Promote accessibility to these sites.

Section 6 ACTION PROGRAM

The action program is presented below in two tables that describe improvements to existing facilities and the development of new facilities. Anticipated funding sources will be in the form of cash from the Township general fund, in-kind labor, and Michigan Department of Natural Resources (MDNR) grants. Sources of the grants are: Land and Water Conservation Fund (LWCF), Michigan Natural Resources Trust Fund (MNRTF), and other appropriate grant programs.

Rationale for planned Banks Township Park improvements

The park improvements and enhancements are planned to improve the accessibility of the site and the site amenities; reduce shoreline erosion risks, enhance access to and enjoyment of Lake Michigan, as well as provide an enhanced park experience for the residents of and visitors to Banks Township. This is a very well used family oriented local park which is in need of some attention to address these needs before they become significant issues.

As an educational element, Banks Township plans to develop a native tree plantation in the Banks Township Park, to promote increased awareness of native plants through interpretative signage. This interest has increased as non-native invasive plant species, such as phragmites, have become more of a threat along the shoreline.

Rationale for planned Community Park improvements

With the archery range at the Community Park, the Village is working with the Ellsworth Community Schools to further promote the sport of archery through educational programs.

The Village of Ellsworth plans to develop a native tree plantation in the Ellsworth Community Park, to promote increased awareness of native plants through interpretative signage. Due to the central location of this park, the Village see this as a prime educational opportunity to take advantage of the increased public awareness of the potential threats caused by non-native invasive plant species, such as phragmites, and help provide information on available and appropriate species native to this region.

A community garden is planned to provide opportunities for families to grow their own garden vegetables in a community environment, and with some community support and assistance for those who do not have any gardening experience. Community gardens are a way to get kids interested in growing plants, and eating healthy vegetables.

Rationale for Property Acquisition:

The ownership of a portion of the property used for accessing the Banks Township Park is currently under investigation. Depending on the outcome of the investigation, it may be necessary for the Township to acquire some additional property to secure legal property access into the future.

Rationale for New Non-motorized Routes:

There is a growing interest in trails both within the community and connecting to a larger trail network. In the recently adopted Antrim County Recreation Plan, one of the identified needs is "develop a connecting trail system". The need for other biking, hiking trails, x-country ski and snowshoeing trails is currently being explored, and should be considered on Village and township properties, as well as connecting routes planned between facilities, parks and places of interest.

Rationale for Snowmobile Connector Routes:

There are a number of snowmobile routes throughout northern Michigan. With the designation of the Ellsworth Community Park as a trailhead parking area for the local snowmobile trails, the Village and Township are interested in expanding the network of trails in the area, and adding connector trails in order to facilitate access to existing trails and from those trails into downtown Ellsworth.
