AN ORDINANCE TO REPEAL ORDINANCE NO. OF 2011 WHICH WAS ADOPTED , AND TO REPEAL ANY FORMER PLANNING COMMISSION ORDINANCE(S), WITH THE INTENT THERE SHALL BE NO PLANNING COMMISSION AT ALL WITHIN BANKS TOWNSHIP
An ordinance to repeal Ordinance No of 2011, which was adopted, and to repeal any former planning commission ordinance(s), with the intent there shall be no planning commission at all within Banks Township, to repeal all ordinances or parts of ordinances in conflict therewith and to provide an effective date.
Banks Township, County of Antrim, Michigan hereby ORDAINS:
SECTION I REPEAL OF ORDINANCE NO. OF 2011
The Ordinance No of 2011, which was adopted, is hereby repealed.
That any previous planning commission ordinance(s) which may have been in effect in is also repealed. The intent is to eliminate the planning commission and so there shall be no zoning in effect at all.
SECTION II DISSOLUTION OF PLANNING COMMISSION
The Banks Township Planning Commission is hereby dissolved, and upon the effective date of this ordinance there shall be no further meetings for the planning commission.
SECTION III SAVINGS CLAUSE
The repeal of Ordinance No of 2011, which was adopted, as provided, shall not affect any rights acquired, fines, penalties, forfeitures or liabilities incurred thereunder or actions involving any of the provisions of said ordinance or parts thereof. Said ordinance repealed is hereby continued in force and effect after the passage, approval and publication of this ordinance for the purpose of such rights, fines, penalties, forfeitures, liabilities and actions thereunder.

SECTION IV SEVERABLITY The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

SECTION V REPEAL

All other ordinances and parts of ordinances, or amendments thereto, in conflict with the provisions of this ordinance are hereby repealed.

SECTION VI EFFECTIVE DATE

This ordinance shall take effect eight (8) days after being published in a newspaper of general circulation within the Township, or when Ordinance No ______, which repeals the Banks Township Zoning Ordinance, adopted May 15, 2000, as amended, whichever is later.
