AN ORDINANCE TO REPEAL AN ORDINANCE ENTITLED "BANKS TOWNSHIP  
ZONING ORDINANCE" WHICH WAS ADOPTED MAY 15, 2000, AS AMENDED, AND TO  
REPEAL ANY FORMER ZONING, WITH THE INTENT THERE SHALL BE NO ZONING  
IN EFFECT AT ALL

An ordinance to repeal the Banks Township Zoning Ordinance, adopted May 15, 2000, as amended, to repeal any former zoning with the intent that there shall be no zoning in effect within Banks Townships, to repeal all ordinances or parts of ordinances in conflict therewith and to provide an effective date.

**Banks Township, County of Antrim, Michigan hereby ORDAINS:**

**SECTION I**  
**REPEAL OF BANKS TOWNSHIP ZONING ORDINANCE**

The Banks Township Zoning Ordinance, adopted May 15, 2000, as amended, is hereby repealed.

Any previous zoning ordinance which may have been in effect is also repealed. The intent is to eliminate all zoning within Banks Township, so there shall be no zoning in effect at all.

**SECTION II**  
**DISSOLUTION OF ZONING BOARD OF APPEALS**

The Banks Township Zoning Board of Appeals is hereby dissolved, and upon the effective date of this ordinance there shall be no further meetings for the zoning board of appeals.

**SECTION III**  
**SAVINGS CLAUSE**

The repeal of the Banks Township Zoning Ordinance, adopted May 15, 2000, as amended and any previous zoning ordinance, as provided, shall not affect any rights acquired, fines, penalties, forfeitures or liabilities incurred thereunder or actions involving any of the provisions of said ordinance or parts thereof. Said ordinance repealed is hereby continued in force and effect after the passage, approval and publication of this ordinance for the purpose of such rights, fines, penalties, forfeitures, liabilities and actions thereunder.

**SECTION IV**  
**SEVERABILITY**

The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word,

section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

**SECTION V**  
**REPEAL**

All other ordinances and parts of ordinances, or amendments thereto, in conflict with the provisions of this ordinance are hereby repealed.

**SECTION VI**  
**EFFECTIVE DATE**

This ordinance shall take effect eight (8) days after being published in a newspaper of general circulation within the Township.
